Uruguay aims to be a regional technology hub, attracting software developers, engineers, and digital entrepreneurs. To ensure further IT nearshoring growth, Uruguay has achieved 94% mobile data penetration nationwide and is expanding its focus to AI & IoT software development. Two initiatives highlight this push — "Open Digital Lab" for IoT testing and Microsoft AI & IoT Insider Lab, launched in 2023.

#### Language


The official language spoken in Uruguay is Spanish, specifically a dialect called Rioplatense, with English being increasingly valued but not widely spoken by the majority.


English language command will vary from very fluent to no English whatsoever in more rural areas. However, it is often fluent in tech hubs and sectors working with international companies.

- According to the English Proficiency Index released by Education First, Uruguay is considered a "Moderate proficiency" country in terms of English ability. Uruguay ranks 8th in English Proficiency in Latin America.





#### Government

Uruguay consistently ranks high in development indicators and is celebrated for its secularism, progressive social laws, and robust social security, healthcare, and education systems. A leader in digital innovation in Latin America, Uruguay is a member of the Open Government Partnership (OGP) and was the first in the region to join the Digital Nations, a coalition of forward-thinking digital governments.

The country's membership in MERCOSUR (a regional trade agreement and economic organization in Latin America), the World Trade Organization (WTO), and its advocacy for the Free Trade Area of the Americas (FTAA) underscore Uruguay's commitment to open markets. Uruguay and the United States maintain a Joint Commission on Trade and Investment (JCTI) to discuss economic cooperation, recently strengthened by a 2024 Memorandum of Understanding (MoU) on emerging technologies.

#### Education

Uruguay has placed a significant emphasis on technology and STEM education through its national initiative "Plan Ceibal," which provides students with digital devices and access to internet, fostering a culture of computational thinking, robotics, and coding skills within the public education system, making it a leader in the region for tech and STEM education access.

Plan Ceibal actively incorporates computational thinking, robotics, and coding into its programs, encouraging students to explore innovative applications of technology.

- The country's provision of free primary through university education has contributed to the country's high levels of literacy and educational attainment.
- Uruguay is often praised for its commitment to tech education, with initiatives like Plan Ceibal serving as a model for other countries in the region.

#### **Economic Outlook**

Uruguay ranks as the 3rd most competitive economy in Latin America and the Caribbean, according to the World Economic Forum (WEF). Its GDP reached USD 77 billion in 2023 (World Bank), reflecting a favorable investment environment supported by steady economic performance over the last decade. Uruguay's growth has been marked by a 1.52% average annual GDP increase over the past ten years, largely driven by private sector investment and foreign direct investment inflows. With a BBB+ credit rating from Standard & Poor's and a BAA1 rating from Moody's, both with stable outlooks, Uruguay's strong and balanced growth positions it as a reliable investment destination, despite challenges such as high government deficits and dollarization levels.
